



# JESSICA QUIST PHOTOGRAPHY

## Wedding Photography Agreement

**1. Exclusive Photographer** - Jessica Quist shall be the exclusive photographer retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they don't interfere with the Photographer.

**2. Deposit, Payment and Remaining Balance** - An initial retainer fee of \$1,000.00 is due upon execution of this contract as a reservation for service. At such time the contract and deposit are received, the deposit will be applied towards the final balance due. In the event of a cancellation, deposits are nonrefundable. If cancellation occurs within 90 days of the date of service, the Client is still responsible for paying 75% of the remaining balance due to the photographer.

**3. Copyright and Reproductions** - Wedding day image files will be released to the Client to download, archive and make reprints for their personal use. For best image quality, all image files are high-res. The Photographer will retain a copy of the original files and owns the right to make reproductions for the photographer's portfolio, self-promotion, website, contests, exhibitions, editorial use, or display within or on the outside of studio.

**4. Client's Usage and Backup** - Photographer authorizes Client to make enlargements of their digital files for their own personal use. Client may not sell, duplicate wedding files as gifts to friends or family or post images for resale on a third party website. Client should make a backup copy of their wedding files and store in a safe dry environment.

**5. Failure to Perform** - If photographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction or the mail. Jessica may substitute another photographer in the event of "extreme" illness or immediate family death. In the event of substitution, a competent professional replacement photographer will be sent to cover the event.

**6. Photographer Meals** - The photographer requests that a seating place and meal be reserved for her and her assistant at one of your guest tables.

**7. Collection Prices, Engagement Portraits, Albums & Tax** - Pricing for packages and services can be adjusted periodically. Future orders will be charged at the prices in effect at the time when ordered. Heirloom Albums are 10x10 inches with 20 pages and 40 images. Engagement Portraits are photographed out on location and include one 8x10 print. 5.6% sales tax will be charged on all collections and orders in the state of Wisconsin

**8. Additional Mileage & Overtime Fees** - If the wedding day activities exceed the timeline agreed upon for service, the Client may request overtime. Overtime requested beyond initial estimate will be billed at \$250.00 per hour. A travel fee of \$100.00 will apply to destinations beyond an hours travel and each additional hour traveled one way.

**9. Arbitration** - All disputes arising under this Agreement shall be submitted to binding arbitration before a mutually agreed upon arbitrator in a court having jurisdiction within the state of Wisconsin. This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. This Agreement shall be governed by the laws of the State of Wisconsin.
